NOTICE OF NEW REQUIREMENT FROM THE INTERNAL REVENUE SERVICE

Secretaries and Worthy Matrons: Please read this important notice to your Chapter and keep this sheet in a safe place for reference—this information is important to your Chapter, so make sure all of your active members know of this [new requirement](#).

If you have not received a communication from the IRS concerning the new requirement for small tax-exempt organizations, you will no doubt be receiving one soon. This notice is to help clarify this requirement.

Note: The Chapter's tax-exemption status will be terminated if this new required filing is ignored.

1. All Chapters whose gross receipts are less than \$25,000 per year will now be required to file annually Form 990-N for small Tax-Exempt Organizations. (This form is called the “e-Postcard”.) The first time you will be required to file is for the year 2007. The information is due on the 15th day of the 5th month after the close of your tax period. Example: If your tax year ends 12-31, you would be required to file by May 15th.
2. The IRS is requiring that this be done online. Those of you who do not have computers will need to find someone in your Chapter who does and who will be willing to help you with this. You may also consider going to the public library to file the e-Postcard.
3. The basic information you will be asked to provide is relatively easy:
 - ❖ Legal Name: (Refer to your Chapter Bylaws for legal name)
 - ❖ Mailing address: This should be the name and address of your Chapter Secretary or the address where your Chapter receives its mail.
 - ❖ Employer Identification Number (EIN): You should have this number in your records. If you do not, you will need to call the Grand Chapter office and have the Grand Secretary give it to you.
 - ❖ A Principal Officer: Your Worthy Matron, or if you like you may use the name of the Chapter Secretary if her address is the same as you have listed for the mailing address of the organization.
 - ❖ Annual tax period: Example: Tax period ends December 31st.
 - ❖ You will be asked to verify that your Chapter's annual gross receipts are still normally \$25,000 or less.
 - ❖ You will need to notify the IRS on this form if your Chapter has consolidated or surrendered its Charter.
