## *Grains from the Past*

*Preserving the Past; Preparing for the future*—

Since this is the month when I reached the age of full Social Security benefits and am no longer eligible to be elected your Grand Secretary, I thought I'd look into the year of my birth, 1943, and see what happened then! I did not look far into that Proceedings book, because on the very first page was a picture of an “American Red Cross Clubmobile”—a Station Wagon type Ambulance. The caption under the picture informed me that FIVE of these vehicles were presented to the American Red Cross for service overseas. They were all purchased with funds contributed by members of the Subordinate Chapters O.E.S. in Nebraska. Worthy Grand Matron Sister Mary Finch indicated in her report that the project started with a letter sent out to the membership asking for a fifty-cent contribution from each member—not unlike our “buck per member” campaigns of recent years. “The response far exceeded our highest hopes,” was her description of the results of the project. The report of the Grand Secretary indicated that a total of \$10,000 was raised for the Red Cross Project. I hope you feel as proud of our history as I did when I read this. I'm hope those who will read the history we are making will be proud of us as well!
