Our Grand Chapter of Nebraska structure allows for great efforts and dedicated hard work at the committee level to be ongoing and beneficial for our jurisdiction's chapters and members.

Those dedicated to our success include:

Board of Grand Trustees

Section 17 of our Bylaws governing our Grand Chapter define: The Grand Trustees shall consist of five (5) members of whom at least two (2) shall be Sisters. The Grand Trustees must be Past Matrons or Past Patrons of a Subordinate Chapter. Each year one (1) member shall be elected, by majority ballot, for a term of five (5) years.

Our Grand Trustees work diligently to guard, guide and direct our budget, insurance and financial transactions. Their leadership is dedicated to our ongoing good health and service as a Grand Chapter.

Grand Chapter Standing Committee for Jurisprudence

Section 26.(4) of our Bylaws governing our Grand Chapter define: The Jurisprudence Committee shall consist of five (5) members who shall be Past Grand Matrons or Past Grand Patrons, and of whom at least three (3) shall be Sisters. The Worthy Grand Matron shall appoint one (1) member for a term of five (5) years, but no one can be appointed to the Jurisprudence Committee after being elected a Grand Trustee until after the term of Grand Trustee is expired.

Our Grand Chapter Standing Committee for Jurisprudence diligently serves our WGM in all questions, documents, papers, decisions of law and its usage. They shall examine all Bylaws and Amendments submitted by Chapters and approve or disapprove the same. They shall consider all resolutions affecting legislation, including the revision or amending of the Constitution and Bylaws and report thereon in writing.

From our Board of Grand Trustees

Wow, what a year! As Chairman of the Grand Trustees, I am including these brief words to you at the request of our Worthy Grand Matron. My best wishes for your continued success.

We are living in unprecedented and perhaps somewhat troubling times, but we can confidently be assured that the leadership of our Grand Chapter has indeed risen to the occasion. They have reached out to our entire state with wonderful, exciting and engaging activities. The Grand Trustees consist of five members, at least two shall be Sisters who must be Past Matrons or Past Patrons of a Subordinate Chapter. Each year one member is elected by a majority ballot for a term of five years.

They exercise a general supervision over the financial affairs of Grand Chapter.

They prepare and submit to the Grand Chapter for action an itemized budget, together with the comparative budget for the preceding year.

JURISPRUDENCE GREETINGS SCHOOL OF INSTRUCTION February 20, 2021

Good Afternoon!

What a year this has been in many aspects. Whoever would have believed there would be a

Pandemic in 2020, let alone it shutting down most normal activities. As with each of you, I miss my Eastern Star friends. Don't let it be said, "You can't teach an old dog new tricks" because thank goodness, we have learned. We have enjoyed the Saturday morning Zoom Coffee Chats and then the Virtual Celebration 1/1/21! Thank you to those talented members who were able to make this happen.

As stated in the **Nebraska Grand Chapter Constitution, Article 3, Section 3 Emergency Session**, "...... the current Grand Officers shall remain in their present offices until the next annual Grand Chapter Session." The **Enduring Hope** Grand Family continues as do the members of the Jurisprudence Committee.

Who are the members of the Jurisprudence Committee? There are 5 members on the Committee. The WGM appoints one Past Grand Matron or Past Grand Patron for a term of 5 years and the senior member serves as the Chairperson. (The current members will, in fact, serve 6 years due to pandemic this past year.). At least three (3) members of the committee must be Sisters.

What does the Committee do?

For the Subordinate Chapters -- If a Chapter wishes to amend their bylaws, please refer to the law and procedure of Section 65 in the Bylaws governing Subordinate Chapters. Obtain the proper form from the Grand Secretary's office and then completely fill out the form in triplicate and send to the Grand Secretary who then forwards them to the Committee. If no conflict with Grand Chapter Bylaws, they are approved and a copy returned to Chapter, one to the Grand Secretary and one for the Committee. If after review the committee felt a change needed to be made, the requests are returned to the Chapter with advice if needed.

For Grand Chapter -- The Committee meets and reviews all resolutions to be presented at Grand Chapter to ascertain they are in proper form. The Parliamentarian may be contacted regarding Roberts Rules of Order. Remember, any member may present a resolution. Per **Section 175 of Bylaws governing Subordinate Chapters**, the

resolutions must be received in the office of the Grand Secretary ninety (90) days before the opening of Grand Chapter. Each Chapter received notification via the OES News that the deadline for 2021 Grand Chapter was **February 10, 2021**.

After General Grand Chapter -- Our law states that any change in General Grand Chapter law is effective immediately in our own Grand Jurisdiction. This Committee then codifies this law with all areas that are affected by these changes. These are then distributed to the Chapters for insertion into the current "Red" Book. The next General Grand Chapter will be held in Salt Lake City on October 29 – November 5, 2021.

For the Worthy Grand Matron -- The Committee is always available to assist the WGM in all matters pertaining to law and its usage. This year with the restrictions, after discussions with the committee, the WGM has sent decisions regarding Chapter meetings to every Chapter.

To every member in this Grand Chapter -- We wish to thank you for remaining steadfast to your Chapter, Grand Chapter and for the benevolent purposes of our Order.

I leave you with this thought "Every day is a new beginning, take a deep breath and start again".
