In 2015, the membership formally adopted Service Dogs as its primary identifying charity and a steering committee was appointed for the triennium to formulate the Service Dog program. Throughout those first six years as the development of this philanthropy began, PGM of Nebraska Betty Kirby was appointed and served on the General Grand Chapter Committee.

In 2017, WGM Anita Sohm appointed as a special committee the original five members who began developing Nebraska Grand Chapter's preparation for the project. At the Grand Chapter session of 2018 the Service and Therapy Dog Committee by vote of the Grand Chapter became a Nebraska Grand Chapter Standing Committee. The General Grand Chapter Service Dogs program was officially launched at the last Triennial Session on November 1, 2018 in Orlando.

In 2019, as the energy and **"paws-i-tive"** impact of the dogs began to grow within Nebraska, the need became apparent to grow from our own ranks a public charity that could build a broader base and serve to enhance the mechanism for future growth. Thus began the legal work and application efforts to form this 501(c)3 public charity. More than a decade of hard work, wisdom and vision are acknowledged tonight as the Board of Directors and first corp of officers are in place to begin this profound next step in the history of our Grand Chapter and the outreach of our Order.
